*CHP and CalTrans has issued permits to close off ramps and intersections for the escort of these veterans.

*Each escort includes flag line as the flag covered remains are transferred to the vehicles. They are processed at Dixon and given full military honors for each veteran.

*It's a matter of getting them off the shelf and buried. One veteran had been sitting on a shelf for 62 years.

*Working with the Neptune Society to process veterans sitting there.
