12. Secretary Report – Debbie Proffitt

- *Deadlines- Rosters need to show a November or December update. Per Capita is due to the Treasurer by December 31. Delegate fees can be paid at the same time but no later than 30 days prior to convention.
- *Last year the rosters were frozen on February 1. This year I don't see a reason to freeze them. It makes more work for me to put in each chapter's delegates and alternates and any membership changes. Since rosters will be printed December 31 there is no need. It was agreed to.
- *Certification of Officers- will be due June 30, 2019. There is a 30 day grace period to end July 30, 2019. After this date COOs are delinquent. I would like to see a wording change in the bylaws to reflect this and to reflect that roster updates are due by December 31 and are delinquent February 1.
- *Working on an online Delegate Report that would generate from the roster.
- *Talked about finding a way to electronic signatures that would eliminate the printing, signing, scanning and THEN emailing to the secretary. Several members suggested Docusign, E sign, etc. It will be looked into.
