American Legion Riders Department of California

The ALR Cup has been established to recognize those Chapters in the Department of California that ride the most miles during the year SAFELY.

Being that we are riders in the Department of California. ALL mileage ridden on a motorcycle, or in a cage if you are a Retired Rider, within the State of California will count if you follow the rules listed below. In addition, any Chapter or member(s) who ride for any Veteran related rides outside the State of California will count under the ALR Cup Rules, such as; Run for the Wall, ALR Western Coast ROMP, National Veterans Awareness Ride and the Legacy Run.

The following are the rules governing the ALR Cup:

- 1) All rides must be a sanctioned ride in support of a Veteran Organization, a Veteran supported event or fund raiser. Examples: Riding for a Poker run to raise money for Vets or Veteran Supported Events, PGR Funerals, Chapter Event/Meetings (Breakfast, Lunch or Dinner) at another Chapter, Honor Flight, Memorial Day, and Parades, etc. Mileage is counted in the following manner:
 - a. From a common starting point (typically your Post) to the event
 - b. Mileage ridden during the event
 - C. Mileage back to common point (typically your Post)
- 2) No matter how many bikes/riders go on the ride, mileage is only counted for ONE bike/rider (i.e. 10 riders go on a 100-mile ride for a fund raiser, you only record 100 miles)
- 3) "Pop-up" rides, Rides of Opportunity and "Social" rides are not to be included in the mileage.

 These rides are defined as a ride that does not support a Chapter, Post or Veteran Organization

 Fund Raiser happening on the day of the ride. Examples:
 - a. Riding as a group for Lunch, Breakfast or Dinner or Harley Dealer.
 - b. Riding to the Lake or City to visit.
 - C. Riding to a Bike Night, not a fundraiser or Veterans Event
 - d. Riding to your Chapter ALR Monthly Meeting.
- 4) If a Rider has a recordable accident (meaning that the riders actions were a result of the accident and is at fault) while on a sanctioned ride, the Chapter will reset their mileage-to-date back to zero and restart their calculations.
- 5) Mileage for the ALR CUP will be recorded from 01 April to 31 March.
 - a. For end of year reports, each Chapter will record their mileage ending 31 March of that year, sent to Area VP for their report. The VPs will forward their area totals to the ALR DOC President for his Report to the Annual American Legion Convention.

The ALR Cup will be presented by the ALR DOC President and Safety Officer at the State Convention. A certificate will be issued to the chapter with the most miles from each Area.

It is the Area VP's and assistant VP's responsibility to monitor the logging of mileage for their respective chapters for accuracy. Any Disputes will be settled by the ALR DOC Safety Officer or the President.
