Financial Report Don Christolear start 57381.95 end 57499.54 Mick Sobzcak 1st to accept report pending audit, 2nd by Nacho, discussion, passed, Budget was proposed from what he sent to all members of DEC, Convention fees have been raised and are put in with Secretary fees, other items were raised based on actual costs, convention seed has been raised too, website fees raised too, plaques cost to be looked at, we are down approx. \$4600.00 from last year, we have to keep it in check, quartermaster sales have been down this year, we have to decide how much we are going to give as donations, a question on what is the tax situation with our lawyer, we do not know how that is going to come out, discussion on how to pay the tax issue if it comes up, VA&R budget discussed as far as how it is designated and spent per the Legion expenses and each Area can have a budget for the VA&R budget, more discussion on patch profits and the dwindling revenue due to members lost and slower growth than we had in the past, per capita increase was discussed and how much it should be, if raised, \$5.00 increase was discussed, Chapters not paying 22-3, 100-3,241-6,249-3, 872-3, 355-3, 456-2, 264 folding, 56 folding, 74 is folded. JA Bart recommended that the chapters not paying be sent notice of possible suspension for failure to pay per capita and/or delegate fees. Suspended status gives the Area VP's the right to go in and have say so in what they are doing and even put in change of officers. A3 JD to cancel the charters of the chapters that are folding, 2nd by A5 Paul Patricio, passed.
